When attempting to find information about the "Smoking Policy," I encountered unsatisfactory search results, particularly when searching in English.

Given that our campus is Sino-American, it is important that the public message and policy be available on the website or publicly displayed in both the local language and English, as initially agreed upon when the school was established.

Regarding Article 6, I would like clarification on whether the intended word is "Designed" or "Designated."

If "Designed" is intended, we should ensure the presence of a "Designed Space" for smoking, whereas if "Designated" is intended, we would expect to see signage indicating "Smoking Permission." Kindly review the policy and announcement to provide clarity on this matter.

Furthermore, I would appreciate an explanation as to why this particular week (May 22 ~ May 27, 2023) was chosen for the refreshment of the policy. If there is a specific reason, it would be beneficial to inform readers accordingly.

Once again, it is important for email recipients to receive clear and essential public messages from the authorities to facilitate cooperation. Your thoughtful consideration in addressing these matters is greatly appreciated.

Thank you for your suggestion and sorry for the confusion the previous email may cause.

According to the Article 6 of the "Campus Tobacco-Control Policies at Wenzhou-Kean University (for Trial Implementation)" issued on November 11, 2015:

"Smoking at academic building, vehicles, classrooms, meeting rooms, libraries, reading rooms, laboratories, canteens, offices, student dormitories, gymnasiums, the corridors, elevator and other enclosed or semi enclosed spaces is forbidden, and non-smoking signs should be set up observably. Except the specially designed outdoor smoking area, the whole campus is a non-smoking area. "

According to the information we got, the inspection team is already in Wenzhou. Since the team may come to our school without any notice, we call on all people on campus not to smoke **on the whole campus** recently, **especially this week**. After this week, the management of smoking behavior shall continue following the policies issued by the school.

Hope this clarification has been helpful. Thank you for the instruction you provide. We will keep on learning and improving to avoid confusions.
